All applicants agree to the following Terms and Conditions in applying to rent a property:

Application Processing Fee is \$35.00 per person. (Everyone over the age of 18 must submit an individual application) The application fee is Non Refundable. If the application is denied for any reasons applicant may choose it to be applied to another property at their request, again no fees will be refunded. Security Deposits vary for each property they are negotiable based upon verified information obtained from application and what the owner feels is a reasonable amount of security deposit for their property.

Or our office will collect money order, cash no personal checks for application fees.

Applicants must submit an application for everyone over the age of 18, along with **Paystubs**, 3 Months, we also require the deposit page of checking account showing only deposits 2 Months. We also need a copy of identification card or driver's license or picture ID.

Our processing time takes between 24 and 72 hours, said applications are only processed Monday – Friday. It may take longer if information for any verification cannot be obtained. This may cause an application to be declined

<u>Guidelines to qualify for renting:</u> Must have legal and verifiable income of approximately 3(three) times the monthly rental rate. Applicant must have reasonably good credit with NO Evictions in the past 10 years, No Current open Bankruptcy proceedings. Eviction or any monies owing to a previous landlord will result in an automatic denial.

Unless advertised all rental agreements have a minimum of a one year lease commitment. There are heavy fees associated with not fulfilling a lease agreement. Please refer to you lease agreement which will outline lease break fees.

Tenants agree that if their application is approved the property will not be taken off the market until the property is secured by the signing of lease agreement and the payment of Security Deposit paid by Cashier's Check or Money Order. (Certified Funds) The securing of the property must be completed within 24 hours of approval given.
